NMAESP & NAESP Membership Categories and Dues *(select appropriate category)*

Active Principal and Assistant Principal, \$335 – Practicing elementary and middle-level principals and assistant principals and related educators receive all NAESP benefits and services including the Legal Benefits Program (\$2 million individual professional liability coverage and up to \$10,000 of liability coverage for job protection defense, based on continuous years of membership), access to webinars, research, online learning, and discounts on ASCA membership, conference registration, and resources.

Institutional Active, \$380 – Includes all benefits of an Active Principal and Assistant Principal plus a duplicate set of publications for your school library.

Emeritus, \$180 – For retired Active Principal and Assistant Principal and Institutional Active. Includes all NAESP benefits and services, including the Legal Benefits Program.

Aspiring, \$130 – Available to all students, teachers, counselors, and others pursuing a career, but not yet practicing, as an elementary or middle-level administrator. Includes most of the NAESP benefits and services. Does NOT include the Legal Benefits Program.
